<b>Key issues discussed</b>	<p>SICAP Update</p> <p>This programme was progressing well with 21 groups and 131 individuals already supported. Significant challenges remain in Co. Monaghan for travellers in terms of social integration, accommodation, health and discrimination which require urgent attention from all relevant bodies including LCDC.</p> <p>Intercultural Network Migrant led groups formed this network, as there was no dedicated place for them to share issues and develop joint solutions. The Intercultural network has overcome problems agreeing suitable meeting times and poor broadband by setting up a Google group (online chat/notice board). This allows network members to share issues and information. It has resulted in group's collaborating on activities such as an Easter treasure hunt.</p> <p>County Monaghan Sustainable Energy Community Baseline report on energy usage in County Monaghan at draft stage. Shows Monaghan well beyond the national average in terms of use of oil for heating.</p> <p>Equality Sub Committee Presentation. This will be available at the June meeting as will be the Local Economic and Community plan update.</p>
<b>Key decisions made</b>	<p>On the proposal of the PPN Reps at the April meeting the format was changed to start with the LCDC Meeting and finish with the LAG Meeting. This reverse in sequence of meetings was prompted by the fact that not enough time was being dedicated to LCDC Business and that too much time was being taken up with decisions on Leader</p>

	<p>Projects at LAG Meetings which needed to be streamlined.</p> <p>As part of the implementation of the Migrant Integration Strategy ‘We Belong’, SICAP worked with the PPN to initiate a new PPN forum for Migrant Community members. This Forum will involve migrant led groups and other interested groups.</p> <p>On the proposal of the PPN Reps from the April meeting it was agreed that a PPN Rep be added as one of two LCDC Reps on the Leader Liaison Working Group</p>
